

## **INTERNATIONAL NGOs, Political Leaders AND NSCN (IM) Nexus IN NAGALAND**

Prior to our independence, Nagas fought against British invasion and Christian conversion. Angami braves of Khonoma, Mezoma and Kekerüma fought against British rule and Christian missionaries for several years in first half of the nineteenth century. The Chakhesang Nagas of Thevopisumi village fought against Christian conversion and church sponsored Naga National Council (NNC) led by A.Z. Phizo – who demanded complete secession from Bharatvarsh. Haipou Jadonang – a Rongmei Naga from Manipur who led a strong resistance to British expansion and missionary menace, was hung on 29<sup>th</sup> August 1931. Rani Gaidinliu – then a girl of 16 years led the movement called Zeliangrong Heraka Movement to protect the sovereignty of the country and defend indigenous Hindu faith. Even A. Z. Phizo who hailed from Khonoma village assisted Indian National Army (INA) led by Netaji Subhash Chandra Bose in the Kohima war during Second World War to defeat British invaders. Even after this resistance, British could establish their rule over Naga Hills area and pushed American and British Christian missionaries into Nagaland under Army protection and Government support. The forced conversion to Christianity and expansion of British rule advanced together. After the grand success in dividing the country by creating East and West Pakistan, the Britishers picked up Phizo and NNC cohorts to create a Christian country in Northeast Bharat.

Firstly, British officers employed Christian missionaries to convert Nagas and then, they (British rulers) asked converted Nagas (Phizo and NNC militants) to start inquisition against those Nagas who refused to convert to Christianity and support British policy after 1947 so that a Christian solidarity could be established with USA and UK by the initiative of American and British Baptist Christian Church for the formation of Christian Sovereign Nagaland. Phizo who supported Army of Subhash Chandra Bose and fought against British army, joined the British bandwagon after conversion to Christianity and waged a war on Bharatvarsh to secede from the country and started Christian inquisitions in support of Christian crusade to convert all Nagas to please his British masters. Anybody who expressed different opinion was brutally killed. NNC and church were all the same. Overnight, churches opened in even remote areas, which became shelter place for guerillas of NNC.

Missionaries acted as informers against army movements and against those Nagas who did not support NNC uprising and Christian inquisition jointly operated by NNC and church. This was the reason that Rani Gaidinliu and her Zeliangrong Heraka (Hindus) movement was the prime target of NNC and Church. They (NNC & Church) were after the head of Rani Gaidinliu – the freedom fighter. British missionary – Rev. Michael Scott became friend, philosopher and guide of Phizo and NNC rebellion. This British reverend supplied lethal weapons packed in Red Cross boxes to NNC militants. The Church formed several NGOs which acted as host to NNC guerillas and Christian crusade. Government of Bharatvarsh under Pt. Nehru couldn't pay requisite attention to what was being done against the country by NNC and Church combine.

### **The Crown Colony Plan**

The Britishers had a Crown Colony plan – a buffer state under British rule, in independent Bharatvarsh by seceding from Siliguri corridor. When it could not happen at the time of secession of both the Pakistans in 1947, they employed NNC guerillas and Church organization to materialize the dream of creating a buffer state in Naga Hills which could be an army base for America and Britain because of NE's strategic location in the midst of Hindu Bharatvarsh, Communist China and Muslim East Pakistan now Bangladesh. With their long experience in divide and rule policy, the marauder masters sitting in London crushed and killed all Naga leaders who opposed annexation of Naga areas with British Crown and conversion of Nagas through force, fraud and proselytisation. That they did through NNC, Church and several Naga NGOs created under the supervision of the British masters planted in Church organizations. Naga club and Naga Hoho were such two NGOs, who were master campaigners and expert educators of NNC and Church agenda amongst Naga

public. When GOI wanted to arrest Phizo for his anti-national activities, he silently escaped to London where he spent a royal life till his death in 1990 hosted by British Church organization under the supervision of Rev. Michael Scott and Billy Graham.

### **Division of NNC**

In 1975 during emergency, NNC signed Shillong Accord 1975 accepting the Constitution of the country. Few hard-core militants defected from the NNC under the leadership of Th. Muivah (Tangkhum Naga), Isak Chishi Swu (Sema Naga) and S.S. Khaplang (Hemi Naga)

because of ideological difference. They went to China for military training and formed National Socialist Council of Nagaland (NSCN) in 1980 under deep influence of Chinese

Communism. This NSCN was again bifurcated into two – NSCN (IM) under the leadership of Isak Chishi Swu and Th. Muivah and NSCN (K) led by S. S. Khaplang. Two years later, NNC was also divided into two – NNC (Adino) and NNC (Yanthan) after the death of Phizo in 1990. Mrs. Adino is the daughter of Phizo and Khadao Yanthan (Lotha Naga) is the former private secretary of Phizo. All the four factions started killing each other in the war of supremacy even after the conciliatory role played by so many NGOs like Naga Hoho, Nagaland Baptist Council of Churches (NBCC), Naga Student Federation (NSF), Naga Mother Association (NMA), Naga People's Movement for Human Rights (NPMHR), and Naga Club (which is dormant now) etc. Several masked NGOs are registered under country's law and also under Foreign Contribution Regulation Act 1976 with a declared aim of serving the society in the field of economic upliftment, hygiene, medical care education and HIV/AIDS. These NGOs are receiving uncountable money from their foreign masters through Hawala and also through all the possible legal and illegal means. In return, they are funding rebel organizations for purchasing lethal weapons. They are also involved in drug and liquor trafficking in Nagaland. These NGOs are involved in other dangerous activity. In the name of eradication of and prevention from HIV/AIDS, there are mushrooming of such NGOs to amass enormous money from foreign NGOs. These NGOs are openly advocating for sex education and free sex but with condoms. They display how a girl and boy can prevent unwanted pregnancy and still keeps HIV/AIDS away even after repeated sex only by the use of condoms designed separately for boys and girls both. The trainer NGOs display condom use in their training classes. Thus, they have targeted to spoil the youths – the most vital section of the society. These NGOs are run by Nagas but these greedy masters of NGOs from Naga community busy to become rich overnight don't bother about the future consequences of their dubious activities sponsored by their foreign masters.

There are two types of such NGOs operating in Nagaland today. First, in this category fall such NGOs which receive money from GOI, foreign NGOs and foreign funding agencies. They declare their aim as working in the field of economic development, education, adult literacy, childcare, hygiene, medical care and environment etc. A large chunk of their money is siphoned off in the terrorist camps. The other type of NGOs are those which work under the garb of student organizations, youth organizations, tribal hohos (apex bodies), civil organizations and human rights organizations. These organizations openly receive money from state governments. In other words, these organizations are nourished by the State Government and foreign funding agencies enemy to Bharatvarsh. These are Government organized Non-Government Organizations (NGOs). That is how the State Government of Nagaland is helping Naga insurgency.

10) **Parliamentarians for National Self-Determination (PNSD):-** PNSD was launched on May 11,2006 in Committee room No.4 in the House of Parliament, Westminster, U.K. Representative from aspiring nation states speaking on behalf

of the **Welsh, Scottish, Naga, Sikh, Kashmiri, Assamese, Manipuri, Kosovar, Kurdish and Tamil nations** as well as other contributors welcomed the formation of this new cross party group and wished its success in mission. PNSD, a cross party group of Westminster Parliamentarians aims to highlight the importance of self-determination as a fundamental human rights as prescribed by international law as well as to promote it as a means of conflict resolution by peaceful and democratic means. United Nations (UN) dominated by US, UK and allied countries played a very destructive role in fragmenting USSR in fourteen smaller countries and division of Indonesia into two giving birth to East Timor – a Christian dominated region after conversion from Islam to Christianity. UN had a similar role in former Yugoslavia, PNSD in cooperation with UNPO and other such NGOs seeks to play a role in promoting the process for self determination initiated by different indigenous groups leading to independence on the line of creation of East Timor.

Lord Nazir Ahmed of Rotherham born in Kashmir and attained Lordship in British Parliament in 1998 became the founder Chairman and Elfyn Llwyd MP its Vice Chairman. Lord Rea who was actively involved in promotion of Chechen and Kurds conflict extended his whole-hearted supports to PNSD. Other members of British parliament who attended the meeting were Pete Wishard MP, Daniel Hannan, a Conservative Member of the European Parliament and Douglas Carswell MP. Th. Muivah, General Secretary of NSCN-(IM) sent Rh. Raising Secretary of Steering Committee of NSCN-(IM) who advocated for Naga independence and requested international community to support NSCN-(IM) in its fight for liberation of Nagalim from India. Rh. Raising expressed full support for Kashmiri self-determination and Sikh struggle for Khatistan. Frans Welman of the Amsterdam based Naga International Support Center (NISC) expressed that former colonial powers such as Great Britain and Netherlands have moral responsibility in helping the self-determination movements in India and else where. Ghulam Mohammed Safi, a former General Secretary of All Parties Hurriet Conference, Nazir Quarashi of World Kashmir Freedom Movement, Zafar Khan of Jammu Kashmir Liberation Front (JKLF), Kashmir Singh of British Sikh Federation, Jaspal Singh Dillan, Vice President of Dal Khalsa, Justice (retd.) Ajit Singh Bains and Navkiran Singh a lawyer who defended many anti-national Sikhs also advocated secessionist movements in Punjab, Kashmir, Nagaland, Manipur, Assam and elsewhere. Others from Northeast region of our country present and spoke in the meeting were Oinam Bhogendra Sigh Chairman of Human Rights Alert Manipur and Dr. Mukul Hazarika of Assam Watch also spoke against the country. PNSD gave a call to reject Bharatvarsh's pursuit of a permanent seat in the UN Security Council Until it signs up key human rights commitments in UN treaties. Simon Hughes, MP, President of Liberal Democratic Party UK extended his all out support to rebellions in Bharatvarsh and elsewhere. R.S. Srain of British Sikh Federation was selected as Administrative Secretary of PNSD. Marino Busdachin General Secretary of UNPO gave a keynote address. Lord Desai chaired the meeting. The political leaders from Welsh and Scottish Parliaments, the Chairman of the Liberation Democrats joined in the debate. PNSD resolved to express its grief at the election of Bharatvarsh to the recently created Human Rights Council of United Nations and urged the blocking of Bharatvarsh's attempt to obtain a permanent seat on the Security Council of UN. It is, thus, evident that PNSD was formed solely for targeting Bharatvarsh and helping NSCN (IM) in Nagaland and other terrorist groups in Northeast region. Lord Nazir Ahmed's association with ISI and Pakistani terrorist organizations active in Jammu & Kashmir and Asom is well known who has been selected as chairman of PNSD.

Boxer is the Chairwoman of the Senate Environment and Public Works Committee. She has held the position of Chief Deputy Whip in minority and as of January 4, 2007 is the Chief Deputy Whip in Majority. More about her: -

2. **Grace Lyu Collins**: - She is Tangkhul lady from UKhrul (Manipur) who graduated from Boston College in 1985 in Fine Arts (Mixed Media and Business), MBA from the University of Durham, UK. She is associated with many NGOs some connected with UN. She met Isak Chishi Swu, the Chairman of NSCN (IM) when she was hosting a Museum of Compassion exhibit for the 50<sup>th</sup> year of Declaration of Human Rights in Geneva, Switzerland. Since then she has been speaking for NSCN (IM) in Churches and art museums. She is appointed as fulltime Honorary Ambassador of NSCN (IM) for mobilizing US, UK and UN support for NSCN (IM). Grace Lyu Collins is registered with Department of Justice, Counterespionage Department as FA# 5566. She delivered a message from USA – “We as American Christians were praying for Naga Christians freedom”. She had brought 42 hand-sized American flags (rolled up like cigarettes) to plant in Naga areas as gifts of encouragement for sovereignty demand of NSCN (IM). The Goodwill Mission to Nagaland on 16-27 May 2007 led by her had sent fifty-one invitations to variety of influential US people including George W. Bush – the US President and Condoleeza Rice – the US Secretary of State for public relation purpose.
3. **Charles Hack**: - He is a journalist with a Brooklyn based chain of weekly newspapers and life style magazines. He is currently staff reporter and photographer with Courier-Life Publications. He is a graduate in journalism from New York University in 2005. He was the member of Goodwill Mission who visited Nagaland during 16-27 May 2005.
4. **John Houtihan**: - He is photojournalist from UK and visited Nagaland during 16-27 May 2005 as a member of Goodwill Mission.
5. **Dr. Sheldon Baker**: - She is founder of Harvest Projects International Inc., earned her Ph.D in Christian education and is an accomplished artist who has exhibited at Pentagon, Senate Rotunda, Lincoln Memorial and various State House. She is a Bible teacher and revivalist. She visited Nagaland during 16-27 May 2007 as a member of Goodwill Mission to Nagaland.
6. **Mark Pritchett**: - He is the Project Administrator for American Christian Trust involved in equipping American Christians to help Christians of the World. It operates prayer centers in Washington DC and Jerusalem. He was earlier a children's Pastor for fifteen years. He was also the member of Goodwill Mission
7. **Leslie Richards**: - A resident of Southern California, Leslie worked for 17 year as a registered nurse specializing in Oncology (Chemo and Radiation) and aids patients. She met Isak Chishi Swu in Washington DC in 2003. She visited Nagaland during 16-27 May 2007 as a member of Goodwill Mission.
8. **Dr. Condoleeza Rice**: - Born to Presbyterian Missionary on November 14, 1954 in Birmingham, Alabama she became the 66<sup>th</sup> Secretary of State of United States on January 26, 2005 replacing Colin Powell. She was previously George W. Bush's National Security Advisor during 2001-2005. Forbe's magazine named her for the World's most powerful women in 2004 and 2005. From 1989 through March 1991, the period of German reunification and the final day's of the Soviet Union, she served in the Bush Administration as Director and then Senior Director, of Soviet and East European Affairs in the National Security Council and a Special Assistant to the President for National Security Affairs. She played a significant role in fragmenting USSR. Now, the same lady is helping NSCN (IM) for dividing our country. Condoleeza Rice, widely regarded as hawk, said shortly before the war in

Iraq; "The United States has always reserved the right to try and diminish or to try to eliminate the threat before it is attacked."

9. **Nazir Ahmed, Baron Ahmed**: - Nazir A.B. Ahmed (b.1958) is Labour Member of House of Lords. In 1998, he was made Britain's second Muslim peer (the first being Henry Stanley, 3<sup>rd</sup> Baron Stanley of Alderley) and raised to the peerage as Baron Ahmed of Rotherham in the county of South Yorkshire. Lord Ahmed was born in Mirpur of Kashmir and was brought up in UK. He founded the British Muslim Councilors Forum in 1992. Ahmed was also made a Justice of the Peace in the same year and chaired the South Yorkshire Labour Party for some years. In 1998 Ahmed was appointed to the House of Lords and took his oath on the Quran.
10. **Prof. Yash Ghai**: - Born in Kenya in an Indian family Prof. Ghai was trained as a lawyer at Oxford and Harvard and was called to the English Bar by the Middle Temple in London. He has been visiting Professor in many countries and is author of several books. He is known as Constitutional expert.
11. **Ms. Victoria Tauli-Carpuz**: - She is an Igorot from Philippines working as a Development Consultant and Indigenous Activist. She is the Chairperson of Economic and Social Development, Culture and Methods of work, gender and women's issues, communication under United Nations Permanent Forum on Indigenous Issues (UNPFII). She is the founder and Executive Director, Tebtebba Foundation (Indigenous Peoples' International Center for Policy Research and Education). She was also the Chairman of Cordillera Peoples' Alliance, Philippines. She has been involved in over a hundred NGOs in USA, UK, and Philippines.
12. **Jimmy Carter and Rosalynn Carter**: - Both husband and wife-the former President of USA are in league with Naga terrorists under the banner of NSCN(IM).

**The American Goodwill Mission to Nagaland**: - A Goodwill Mission team from USA visited Nagaland on May 16-27, 2005 and prepared a white paper and signed (?) affidavits regarding 'genocide' (as the mission team preferred to call it) committed by Govt. of India in the past and present on the Naga 'Nation' (that is how the mission report referred Nagaland). This report was to be registered with the Department of Justice (of USA), disseminated to US officials and finally presented to Kofi Annan, Secretary General of United Nations for further actions. Naga Mother Association (NMA) and Naga Student Federation (NSF) hosted the mission team and these two hosts facilitated the teams' movements in and around Nagaland. In a letter enclosed with highly malicious and anti-Indian report addressed to George W. Bush, President of USA, the team members requested Bush to use his wisdom, moral conscience and international

clout to influence Govt. of India to (i) withdraw their 2,50,000 army troops (Is it correct number?) from Nagaland (ii) repeal the Indian Constitutional Laws (a) Armed Forces Special Power Act, 1958 (AFSPA, 1958) and (b) Restricted Area Permit (RAP) because of which more than 3,00,000 (three lakhs) lives were lost. (Even Nagas wonder from where they collected this number). They have requested Bush to denounce India as "World's Largest Democracy" as Christians suffered at the hands of Hindu extremists. (Who are they?). Bush has been requested to extend financial assistance directly to Naga's Govt. (Govt. of People's Republic of Nagalim (GPRN) of NSCN-IM) since they have many natural resources to offer (to USA) such as vast oil reserves, uranium and gold. It is stated in the letter that Naga people loyally fought side by side with America and allied forces in both World Wars, now it is time for those allied forces to support Nagas. (Nagas under the leadership of A.Z. Phizo fought side-by-side Indian National Army-INA led by Subhash Chandra Bose against allied forces led by USA and UK) It will not be out of context to remind how USA/UK combine fought war on behalf of Kuwait and defeated Saddam Hussein of Iraq to squeeze crude oil and other minerals from those countries. This combine has fragmented USSR into fourteen smaller countries, separated East Timor (now a Christian dominated country) from Indonesia (a Muslim country but with Indian heritage) and still helping Pakistan

and Bangladesh to foment terrorism in Jammu & Kashmir and Northeast region besides other parts of our country. The mission's letter to Bush advised that US Govt. and United Nations should take a closer look on Naga peace talks, monitoring the Cease-Fire Agreement between National Socialist Council of Nagalim - Isak-Muivah (NSCN-IM) and GOI, developing a US presence in Nagalim and assisting in Nagas' desire for full-fledged independence. The letter complains that Govt. of India has not offered any solution even after 60 rounds of talks. They have proposed that international intervention is required to fulfill their demand of interdependent co-federal relationship. This "interdependent co-federal relationship" is latest coinage of NSCN-IM to camouflage their sovereignty demand. The letter was signed by US citizens- (i) Grace Collins (ii) Leslie Richards (iii) Mark Pritchett and (iv) Dr. Sheldon Baker. **The American Goodwill Mission visited Nagaland with an aim to concretize a rational for the American people, US Government and UN to get involved in the conflict politically and financially as a means for Nagalim (Naga country) to eventually gain recognition as a sovereign nation.** The mission report stated that Nagas satisfy the necessary conditions under international law to exercise their right to self-determination because of this Nagas have the right to armed resistance. That is why, the US Government and other UN members should start holding their fellow UN member India accountable to violating 24 out of 30 Articles of the Universal Declaration of Human Rights on the Naga People.

**Role of Church:** - In 1872, American missionaries entered into Nagaland and forced Nagas to convert to Christianity. Angamis of Khonoma, Mezoma and Kekrima revolted against British Rule and Christian conversion Haipou Jadonang, Rani Gaidinlui of Manipur and Chakhesangs of Thevopisumi village too revolted against them. As the saying goes on – Bible follows the bullet, Nagas were converted at gunpoint. After 1947, Naga National Council (NNC) under the Chairmanship of Phizo formed a nexus with American Baptist Missionaries. Rev. Michael Scott – a British missionary was friend, philosopher and guide of Phizo and NNC. He was, later expelled out from the country by Nehru. The Church psychologically weaned away Nagas from Indian society and incited them to wage a war of independence against India. They distorted the history of Nagas and compiled concocted stories in book form to drive Nagas away from national mainstream. This war still continues. The Church worked on following four-points:

-

- (i) Create a minority by converting Nagas to Christianity
- (ii) Give them nationality
- (iii) Generate insurgency to revolt against elected Government and
- (iv) Give military training to armed militants to fight against their own country.

In the case of Nagas, Church is quite successful in their conspiracy against the country to sever the joint at 30 km. wide Siliguri corridor from rest of the country. The Naga insurgency has come a long way and the enlightened section of Naga society realize today the futility of militancy by misguided section of Naga society. The Naga militants are fragmented in several groups but Church acts as their Godfather providing an umbrella for all of them. NSCN (IM) led by Isak Chishi Swu, Chairman and Th. Muivah, General Secretary is comparatively stronger militant group. The local and international Church Organization and Local and international non-Governmental Organizations are now very thick with NSCN-IM and they are helping it in all respects. **With a view to internationalize the domestic problem pertaining Naga society, this American**

**Goodwill Mission toured Nagaland on 16-27 May 2007 and tried their level best to establish Christian solidarity with US Christians.** Nagaland Church has also come forward in establishing this solidarity by declaring the State as "Nagaland for Christ" where only Christianity is recognized religion. The conversion to Christianity and Naga insurgency were supplement to each other. The Church and militant organizations were helping each other. Nagalim is the proposed Naga Country advanced by NSCN-IM, which is almost nine times bigger

than existing Nagaland including almost three-fourth of Manipur, large portion of Arunachal Pradesh and Asom. With help of international Church organizations and foreign NGOs, NSCN-IM has several support centers in Netherlands, Thailand, Denmark, Germany, Estonia, South Korea, Australia, England, Philippines, Sweden, Belgium and US. It has reportedly nearly 3500 strong trained militants.

**America has a reason to help NSCN-IM** – There is no Christian country in third world. Right from Israel up to Japan including the countries like Iran, Iraq, Afghanistan, Pakistan, China, Bangladesh, Bharatvarsh and other smaller countries, there is no Christian country and nearly 375 crore population live here. This is the pain of nexus of USA, UK, and Vatican. They want to create a Christian country and Greater Nagaland which NSCN-IM now refers as Nagalim, if carved out, will be the proposed Christian country in the subcontinent. This strategy of America is an echo of Popes declaration– ‘The Europe was won over in first millennium, Africa and America in second millennium. Now in third millennium Asia must be own over’. In Asia, Communist and Muslim countries have banned the preaching of Christianity. And that is why the Bharatvarsh is at the top of the hit list of their targets because of Hindus tolerance. And the means are Bible (forced conversion) booze (destruction of youths by preaching the philosophy of hedonic consumerism, liquor addiction and carnal pleasure) and the bullet (the way NSCN-IM is operating in Arunachal, Manipur and Nagaland for forced conversion). Because of its strategic location, Northeast Bharatvarsh is prominently shown in the map of conversion plan of US/UK combine and Vatican/Pope’s mercenaries. American Parliament has constituted a committee to help NSCN (IM) and that committee is called as **Senate Foreign Relations Committee on Nagaland**. Lady Barbara Boxer-Democrat Senator from California and Grace Lyu Collins-the registered US Foreign Agent and Honorary Ambassador of NSCN (IM) are the architect of this committee (The Morung Express 10/12/2006). The US Consul General in-charge of Northeast Bharatvarsh stationed at Kolkata-Henry V.Jardine visited Nagaland in 2<sup>nd</sup> week of December 2006 and met various political leaders formally and underground and Church leaders either secretly or informally to avoid media attention. In fact, the office of US Consul General in-charge of Northeast region is a hub of activities supporting Naga secessionist movement clandestinely. Almost all preceding US Counsuls General posted at Kolkata paid visits to Nagaland. On some occasions, their visits were cut short because of their malafide intensions, clandestine activities and their hob-nobbing with Church and secessionist Naga guerillas.

I have ventured to run an investigation into the US government’s disturbing support to evangelical organizations engaged in Church-planting, intelligence gathering and conversion across the country. Simultaneously, I ran an investigation into native NGO’s and foreign NGO’s dubious role to disintegrate the sovereignty of Bharatvarsh with special reference to Nagaland and NSCN(IM). These NGOs and Church organizations are supported by Central Intelligence Agency (CIA-USA) and Inter-Services Intelligence (ISI-Pakistan). The Bush administration has encouraged Christian faith-based organizations like no other administrations before, their conversion campaign runs world-wide but Bharatvarsh is a major laboratory-they are using everything from classical conversion techniques to state-of-the-art technology in their efforts. Over the past decades, American, British, Australian and other foreign missionaries have repeatedly violated the law banning their entry by coming in on tourist visas and carrying on with conversion and Church-planting in Nagaland. These Churches are base-centres of NSCN(IM) and other Naga terrorists. The Naga missionaries and Church activists are zealous converters and harbinger of Naga secessionist movement prodded on by their American and British masters. Now, the Christianity has become a corporate or political campaign for Naga politicians like Neiphiu Rio-former Chief Minister of Nagaland and his political partner-BJP(Nagaland).

In a major policy decision taken very early into his presidency, Bush on January 29, 2001, unveiled a “faith-based” social service initiatives that included a new

White House Office to promote government aid to Churches and Christian faith-based NGOs. This, in effect, threw the massive weight of the federal government behind religious groups and religious conversions. **The Office of Faith-Based and Community Initiatives was set**

**up in the White House in the first week of February 2002 and a man called Jim Towey was appointed as Director. Jim Towey was the legal Counsel to Mother Teresa in the late 1980s.** This is Bush's "return gift" to the Christian Right for having loyally supported his Presidential campaign. This is also for retaining his "vote bank". After all the Far Right Christian evangelists have also been the most loyal backers of Bush's hard-line militarism in Afghanistan, Iraq and elsewhere.

But there is another perhaps more important reason why Bush is keen on supporting his evangelist friends who run huge Transnational Missionary Organizations (TMOs). In the decade 1990-2000 they ran a global intelligence operation so complex and sophisticated that its scale and implications are no less than staggering. **This missionary-run intelligence operations have put in place a system which enables the USA government to access any ethnographic information on any location virtually at the click of the mouse.** This network in Bharatvarsh established with funding and strategic assistance from US-based TMOs gives US intelligence agencies virtually real time access to every nook and corner of the country. Bush supports those TMOs (Transnational Missionary Organizations) who fund and strategize conversion activities in this country with more thrust in strategic locations like Nagaland, Arunachal Pradesh, Manipur, Meghalaya, Tripura and other NE states. **Organizations like International Mission Board, South Baptist Convention, Christian Aid, US Aid, World Vision, Seventh Day Adventist Church and multi-billion enterprises run by evangelists like Pat Robertson, Billy Graham and Roger Houtsma-amongst many others were instrumental in running a coordinated conversion campaign in Bharatvarsh under the banner of AD 2000 which later became a Joshua Project.** After a decade, Joshua Project II was launched to sustain the time bound conversions and intelligence gathering. Graham's TMO-Billy Graham Evangelist mission supports conversion activities in Gurgaon, Haryana, Kolkata and Northeast region particularly Nagaland. AD 2000 (Joshua Project) conceived for Bharatvarsh was planned based on a military model with the intent to invade, occupy, control and subjugate its population. The idea was to send out spying missions to source micro-details on religion and culture and foment communal uprising in Hindu society in the name of Dalit, untouchability, ethnicity, caste, creed, language and class. The movement that took shape over the 1990s, has now taken off because of a unique collaboration between American government and US based evangelical mission agencies. In the 1990s, this movement was shaped by the World Evangelical Fellowship-an international alliance of national evangelical alliances working with Ad 2000 movement with an assigned goal of achieving **"a Church for every people and the gospel for every person by the year 2000"**. Its focus was missionary mobilization and church planting in Bharatvarsh and other regions of the world where the Christian population was negligible. **This movement was also a massive intelligence gathering exercise funded and supported by American missionary organizations that were responsible for the election of George W. Bush.** North and Northeast region of Bharatvarsh were strategically important for the missionaries. **What made things easier was the new buoyancy in Indo-US relations.** Tremendous energies have been spent on "spying out" the land and its inhabitants. **The missionary goal is to set up a Church within cycling distance, then within a walking distance and finally within hearing distance. This American mission mandate is on in full swing.** There are thousands of Church pastors, reverends, evangelists, laity, priests and clergymen on pay-roll of Central Intelligence of America (CIA) who are posted in the Churches of Nagaland and NE states and other strategic places of North Bharatvarsh. They are handsomely paid for supplying classified informations with regard to military-bases, army-movements, defence strategies, maps of strategic

places, roads linking international borders, defence factories, thermal power stations, fuel installations, Science Research Centers etc. The collaboration between American missionaries now replaced by Naga missionaries, CIA and NSCN(IM) is working on creating a Christian country – Nagalim which will be a base for America and Britain.

### **The Americans Committed to Christ**

1. **George W. Bush**: - By virtue of being President of the United States, he is probably the most resourceful and influential Christian missionary ever. The White House under him is not too unlike a bastion of Christian fundamentalism.

In early November last year Bush told a cheering crowd at the Dalias Christian youth Centre: "If you change their heart, then they change their behaviour. I know, "An indefatigable crusader for Christianity, Bush often holds forth on his own conversion, which led him to give up alcohol. At forum after forum, he has coaxed fellow Americans to follow his personal example.

No surprise, then, that his personal beliefs find expression in the official support that his administration gives to Christian faith-based organizations. His foreign policy decisions, especially those that involve funding decisions related to development and humanitarian issues, are imbued with covert help to Christian NGOs and evangelist groups.

No surprise either that he appointed Lt. General William Boykin to head the hunt for Osama bin Laden. Boykin, a regular speaker at evangelical Christian meetings, once said the war on terror was a fight against Satan. That's the battle Bush probably sees himself waging the battle for faith.

A recently published book, *The Faith of George W. Bush* by Stephen Mansfield, has detailed instances to show how Bush's faith influences his political thinking. The book revealed his belief that his presidency was pre-ordained. In the run-up to the presidency he told a Texan evangelist, James Robinson, about a premonition he had; "I feel like god wants me to run for President. I can't explain it, but I sense my country is going to need me. Something is going to happen..... I know it won't be easy on me or my family, but god wants me to do it."

Once a binge-drinker and hardcore party animal, Bush changed after an encounter with evangelist Billy Graham. Reams and reams have been written on the conversion of George Bush Junior.

But perhaps the goodbye-Jack Daniels-hello Jesus move was one of the smartest he has made in his career. He found 'new strength' through his belief in Jesus: he gave up drinking in the summer of 1986. During Bush Senior's campaign Bush Junior became the liaison-man to the religious right, a powerful lobby that he assiduously cultivated from 1987 to the time he became Governor of Texas in 1994. A year before he became the Governor he created a flutter in Austin, Texas, when he told a reporter that only believers to Jesus go to heaven. But the Southern right wingers loved him for that. They have been with him with all their power since. Their role in Bush's ascendancy to Presidency is not insignificant. It is not surprising that the White House and the Bush administration are choc-a-bloc with Christian right wingers-key officials and advisers, top bureaucrats, backroom players, all come from the same Christian Right-wing pool.

2. **Condoleezza Rice, National Security Advisor**: - Her name was inspired by a musical notation 'condoleezz.' But Condoleezza Rice's inspiration stems from the Lord above. A committed Christian, she is the first women to serve as National Security Advisor and is arguably the 'worlds most powerful women.' Rice, 47,



daughter of a Presbyterian pastor, makes no bones about her strong Christian leanings and often turns to the Bible for inspiration when waddling through rough patches. Romans 5 is her favorite read from the scripture, when in need of strength and guidance. Romans 5 implies: "God is also in tribulation. Because tribulation breeds perseverance and perseverance patience and with patience comes hope. And hope is never disappointed, because of faith in glory of God." "When I am concerned about something I figure out a plan of action and then I give it to God. I just ask it to be carried through it. God's never failed me yet," she said to Essence magazine in 2002.

Her religious moorings were also on evidence during the war of Iraq. She told Business Week last year: "This campaign (against terror) has put a certain moral clarity back in international politics.....(The aim is) to leave the world not just safer.....but better." A wall Street Journal reporter in his book George W. Bush, the White House, and the Education of Paul O' Neill summed up the mood inside the White House one evening during the war.

"A two-day crisis meeting of Mr. Bush's senior advisers had finally wound up. The President had gone to bed. Across the room, the National Security Adviser, Condoleezza Rice, was singing hymns, accompanied on the piano by the Christian fundamentalist Attorney General, John Ashcroft."

3. **John Ashcroft, Attorney General**: - He is considered the architect of Bush's 'charitable choice' policy. Ashcroft amassed a solid right-wing record in his years in the US Senate and as Governor and Attorney General of Missouri. Ashcroft was a key proponent of such right-wing issues as government-funded religion and anti-abortionism. Before Ashcroft announced he would not seek nomination, many religious right leaders considered him to be their top Republican pick for the Presidency in 2000. Lines from a speech he delivered at the Bob Jones University- "Unique among the nations, America recognized the source of our character as being godly and eternal, not being civic and temporal. And because we have understood that our source is eternal, America has been different. We have no king but Jesus...."

4. **Theodore Olson, Solicitor General**: - One of the most prominent ultra-conservative lawyers in Washington, Olson came to Washington in 1981 to work in President Reagan's Justice Department and later represented the former President during the Iran Contra scandal. He has served on the boards of various right-wing foundations and think tanks. Olson was also the head of the DC chapter of the right-wing Federalist Society.

5. **Michael J Gerson, Director of Presidential Speechwriting**: - Worked for Charles Colson's Prison Fellowship Ministry. He also worked as a senior policy adviser at the Heritage Foundation. An alumnus of Wheaton College, Gerson is a born again Christian and has an evangelical outlook.

6. **ASA Hutchinson, Administrator, Drug Enforcement Administration**: - This former Senator is a long-time favourite of the religious right. He has spoken repeatedly at the Conservative Political Action Conference, an annual conference attended by the nation's staunchest right-wing political activists, demanding ban on interracial dating only in March 2000.

### **Us Based Christian Evangelical Organizations That Have A Significant Presence In Bharatvarsh**

1. **India Campus Crusade for Christ**: - It is an Indian associate of Campus Crusade for Christ, Inc, that is based in Orlando. In 1998-99, it raised around Rs 1,600 crores through several affiliated organizations. Being an evangelistic organization, it promotes Christianity in various ways including through sports (Athletes in Action). In India, it works in tandem with **World Vision** and **Indian Evangelistic Mission**. It ranks in the top 25 FCRA list, and evangelists told Tehelka during its field investigation that it is involved in conversion activities. Its annual growth rate is 29 percent.

2. **Seventh Day Adventists**: - It is registered in Tamil Nadu as a company called **Service Association of Seventh Day Adventists Pvt. Ltd.** It consciously guards its plans and nature of activities. It received Rs 19.6 crores and Rs 27.5 crores in 1996-97 and 1998-99 respectively. Figures for the other years were unavailable. However, the available figures reveal that between 1996 and 1999, the Seventh Day Adventists in India grew by a whopping rate of 18.5 percent. **The Church has reported a real hunger for Christianity in India. It has constructed more than 230 new Churches in Punjab, Haryana, West Bengal and Rajasthan and claims more than 65,000 new followers.**

3. **Gospel for Asia**: - Funded by its parent organization in the US, Gospel for Asia, is registered in Kerala. It received Rs. 26.1 crores and Rs. 14.4 crores in 1996-97 and 1997-98. Gospel for Asia, founded in 1979, is a US-based Christian Missionary organization. It aims to spread the teachings of Christ. It also trains and supports missionaries and sets up Churches. In 1999, it raised Rs 70 crores. Of this, about Rs 52 crores was spent on direct programme. The Indian branch receives around ¼ of the total budget.

4. **Watch Tower Bible and Tract Society**: -It is an Indian associate of Watch Tower Bible and Tract Society of Pennsylvania, and a part of Jehovah's Witnesses (JW). Located in Lonavala and registered in Maharashtra, it received Rs 14.6 crores in 1997-98. It provides free Bible courses. Since 1926, JW have printed 10 crores copies of the Bible in 34 languages.

**Lokshree Dr. S.C. Jamir – the biggest hurdle in NSCN(IM)'s path**: - Prior to Ceasefire Agreement on 1<sup>st</sup> August 1997 with GOI under H.D. Devegowda and NSCN-IM, the latter was breathing its last. Th. Muivah was openly advertising in local media for recruitment in his armed cadre. When there was no response from Naga youths, NSCN-IM was offering an amount of Rs. 5,00,000/- (Rupees five lakhs only) in addition to fabulous monthly salary. Even after that they were not getting response from Naga youths. Meanwhile, H.D. Devegowda succumbed to international pressure and entered into Cease-fire Agreement in 1.8.1997. This provided a lease of life to NSCN-IM. They collected crores of rupees through extortion and from international NGOs through hawala and other illegal means. NSCN-IM guerrillas came on the road while military jawans went to the barracks. Dr. S.C. Jamir was the Chief Minister of Nagaland. He was not consulted about the Cease-fire Agreement. He opposed it. The army was also opposed to this agreement. What convinced GOI to enter into such dubious agreement is still a mystery. Since Dr. S.C. Jamir was opposed to sovereignty demand of NSCN-IM, Muivah tried to kill him. Almost half a dozen time, there was an assassination bid on Jamir's life. In 1993, Jamir was brutally attacked by NSCN-IM militants in

Nagaland House, New Delhi. His body was riddled with bullets. Luckily, the doctors of All India Institute of Medical Services (AIIMS) saved his life. In 1995 NSCN-IM guerillas sprayed AK-47 bullet in Kohima from close range at Jamir's car when he was returning home after visiting his daughter's place. The impact of the bullets threw the car down 30 metres below the steep slope until it dashed against pine tree and stopped. Inside, Jamir and his wife were found live with minor injuries. In 1999 in between Piphema and Medziphema, fourteen powerful bombs were detonated simultaneously followed by a hail of AK-47 bullets from three sides when the Chief Minister Shri S.C. Jamir's convoy was passing through a narrow stretch of NH-39, the extreme steep terrain. The bombs missed the Jamir's car and he was safe. But a hail of bullets from sophisticated weapons killed two security personnels on the spot and wounded several more. Jamir escaped miraculously. It was so sad and unfortunate that Vajpayee Government at Delhi remained silent over the incident. This year (2007) in the month of November, the NSCN-IM declared Dr. S.C. Jamir Governor of Goa as anti-national, anti-Naga, traitor and so on. It ordered S.C. Jamir not to enter into Nagaland or else face the consequences. The Democratic Alliance of Nagaland (DAN) Government led by Neiphiu Rio and joined by Bharatiya Janata Party (BJP) as the coalition partner shockingly remained silent. The reason of their silence is that they captured the political power in 2003 State election when NSCN-IM had hijacked the election and directed the voters at gunpoint to vote only DAN candidates. How can a separatist organization ban the entry of a Governor of Indian State into Nagaland? The stunning silence of Union Government is equally shocking. On 24 November 2007, Goa Governor was ambushed at Changki village in Mokokchung district of Nagaland while he was retuning to Dimapur after visiting his home district. Five IED's exploded on the spot of ambush followed by rain of AK bullets from two sides to ensure the sure death of Governor Dr. S.C. Jamir. Two-inch mortars thrown at Governor's vehicle miraculously failed to explode. Besides, the police found another improvised explosive devices (IEDs) which could not be triggered off. Governor Jamir escaped unhurt. NSCN-IM became most sad on its failure to assassinate Jamir this time too. When spontaneous condemnation of NSCN-IM poured in the media by several NGOs, civil organizations and the public, NSCN-IM simply said- it was stage managed to gain cheap popularity and public sympathy. Neiphiu Rio led DAN Government (the conglomeration of Naga People's Front-NPF and BJP) brushed it off as a minor matter under "political problem" category. Dr. Man Mohan Singh Government also proved to be weak and meek in condemning the heinous deeds of NSCN-IM. Such complacency of Delhi discourages the patriotic Nagas who keep Kohima attached with Delhi at the risk of their lives and other family members.

**Neiphiu Rio is the best Chief Minister–NSCN(IM)**– American Church led Goodwill/Facts Finding Mission led by Grace Lyu Collins—a Tangkhul lady from Ukhrul town of Manipur and fulltime ambassador of NSCN-IM in Washington DC, visited Nagaland on 16–27 May 2005. This American Goodwill Mission adjudged Neiphiu Rio as the best Chief Minister Nagaland has ever had. They condemned Dr. S.C. Jamir as Indian puppet. This is the same Neiphiu Rio who gave free hand to NSCN-IM and resolved to pay

Rs 60,00,000/- (Rupees sixty lakhs only) each financial year to Church for developmental work. He is the same Chief Minister who took up the "plight" of Christians throughout the country in Chief Ministers Conference chaired by Prime Minister Dr. Manmohan Singh and asked Prime Minister Manmohan Singh to punish Hindutvavadi "fanatics". Again, he is the same Chief Minister who has asked Union Government to prevail on Myanmar to stop Army operation against Christian missionaries and Naga militants. It was NSCN-IM because of which Neiphiu Rio could ascent to the thrown of Chief Minister. In return, Neiphiu Rio is obliging NSCN-IM.

In our country, Human Rights and Communists are two much talked of terms which are synonym to anti-Hindu and anti-national. They operate in camouflaged garb so that their criminal and anti-national activities are not detected. These

Human Rights and Communists reward each and every individual and NGO who serve them sincerely. This is the reason Neiphiu Rio was rewarded with "**National Human Rights and duties Award 2007**" by Indian Institute of Human Rights, New Delhi on 11 December 2007 on the occasion of 9<sup>th</sup> world Human Rights Congress and Human Rights Day at India International Center, New Delhi. All the underground organizations, their over ground wings working in the garb of youth organization, tribal organizations, NGOs, Human Rights Organizations and Church bodies agitate to scrap **Armed Forces Special Power Act 1958 and Restricted Area Permits** because both the Acts restrict their anti-Indian activities and conversion crusades. Neiphiu Rio is the severest critic of these two Acts. When Dr. S.C. Jamir was ambushed on 24<sup>th</sup> November 2007 at Changki village (Nagaland) by NSCN-IM, Rio dilly-dallied to serve the cause of his Godfather. Neiphiu Rio acts as the counselor of NSCN-IM and International Church bodies with the help of BJP leaders in state and Delhi. He is successful in his nefarious game plan. More than 20 thousand Christians in over 100 Churches in the Churachandpur district and elsewhere in the northeastern state of Manipur launched a prayer campaign for freedom and democracy in Myanmar on October 21, 2007 expressing solidarity with political prisoners and the democratic leader Aung San Suu Kyi who is a Christian convert. Her husband is another devout Christian. The campaign was organized by Myanmar Christian Fellowship (MCF) comprising Burmese Christians in exile in collaboration with Nagaland and Manipur Church Organizations and Human Rights Alert of Manipur. In the name of Christian solidarity, the Myanmar Church is trying to establish close relation with USA, UK and other Christian countries. Neiphiu Rio never loses any such opportunity to show his Christian solidarity and this time also he wrote a long letter to our Prime Minister Dr. Manmohan Singh to pressurize Myanmar Government not to disturb Naga undergrounds. These Naga undergrounds are helping Aung San Suu Kyi in the name of Christian solidarity. (The Morung Express 24/10/2007 and Northeast Herald 21/12/2007). Nagaland Chief Minister Neiphiu Rio added another feather to his cap when he addressed the inaugural programme of the two day International Conference on Empowerment of Dalits and Minorities through Education and Employment which was organized by All India Forum of legislators, SCs/STs on 17<sup>th</sup> May 2007 where Dr. APJ Kalam, President, Dr. Manmohan Singh, Prime Minister and Sonia Gandhi, Chairman of UPA were present. More than 200 MPs, Governors and Chief Ministers from all over the country attended the Conference. Neiphiu Rio strongly condemned the passing of Freedom Religions Bills by different states in his speech. He said that because of these bills, the conversion to Christianity by Christian missionaries are held illegal and punishable act. This is the reason that Christian missionaries are punished and harassed. Rio appealed to Sonia Gandhi and Govt. of India to grant rights to the reservation for dalit and tribal Christians. While appreciating Neiphiu Rio for advancing the Christian cause, Rev. Zhabu Terhuja, General Secretary of NBCC said, "This was not the first time that Neiphiu Rio has expressed against the religious suppression against Christians in India, last year also he opposed the passing of anti-conversion bill in Rajasthan Assembly." (The Morung Express 22/05/2007). Sam Paul, Secretary, Public Affairs, All India Christian Council (AICC) sent warm greetings to Rio for his 'brave' task. Sam Paul wrote, "Thank you for your firm statement on the fallacy of anti-conversion bills in several states at the International Conference on Empowerment of SCs, STs and Minorities convened by Charanjit Singh Atwal, the Deputy Speaker of Lok Sabha" (The Morung Express 22/05/2007). It may be remembered that on being sworn as Chief Minister, what Rio first did was granting of 60 lakhs rupees to Church each financial year for advancing Christian activities.

**The BJP Factor**: - The BJP unit was established in 1986 in Nagaland with Pius Lotha, advocate as its founder ad-hoc President. Afterwards, N.C. Zeliang took over as the President and he created a BJP cadre in Nagaland committed to BJP ideology. When Satish Velankar took over as the Coordinator of BJP in NE region, BJP lost its path. On the eve of 2003 assembly election in Nagaland, V. Satish mooted the idea of forming

Democratic Alliance of Nagaland (DAN) with Nagaland Peoples Front (NPF) headed by Neiphiu Rio. N.C. Zeliang opposed the idea when he sensed NSCN(IM) supporting Neiphiu Rio and his newly born party–NPF. V. Satish over-ruled N.C. Zeliang. And DAN was formed with BJP and NPF. Several opportunist political leaders who were ministers in S.C. Jamir Government defected from Congress and joined BJP. DAN had “go-ahead” signal from NSCN(IM). V. Satish was successful in his nefarious game-plan and he could convince BJP high command in favour of BJP, NPF and NSCN(IM) nexus. NSCN(IM) hijacked the whole election process. Because of this, BJP got seven MLAs and Neiphiu Rio could form the Government. Atal Behari Vajpayee – the Prime Minister and L.K. Advani – the Deputy Prime Minister in-charge of Home Affairs granted freedom to NSCN(IM) to sport lethal weapons and direct the voters to vote for DAN candidates. Since the BJP and NPF came to power in Nagaland under the banner of DAN with the help of NSCN(IM), BJP alongwith NPF leaders is paying back to NSCN(IM) at every available opportunity. NSCN(IM) is making full use of BJP and NPF. Of course, for this favour, BJP leaders are suitably rewarded. It was because of this reward, V. Satish supported Neiphiu Rio’s proposal for granting rupees sixty lakh each year to Nagaland Church from Govt. treasury. It was also because of this reward Vajpayee Govt. agreed to extend Cease-fire in all Naga inhabited areas in Manipur, Arunachal Pradesh and Asom and eighteen Manipurians were gunned down by security forces on 18 June 2001 during a protest rally in Imphal. All the time when NSCN (IM) attacked S.C. Jamir to kill, BJP stood with NSCN(IM)’s killer brigade and condemned S.C. Jamir only whereas S.C. Jamir took risk to his life and family members for unity, integrity and sovereignty of Bharatvarsh. After a month of Nagaland election, Advani boasted in Mumbai Sammelan “BJP has created a history in Nagaland by winning seven MLA seats in recent Nagaland assembly election.” The people of Nagaland laughed at Advani for his bogus statement. Advani had, earlier, got Muivah released from Bangkok jail. Vajpayee met Muivah and Isak in foreign lands many times (Paris on 30.9.1988 and Osaka on 8-11 Dec. 2001). He also met them in New Delhi on 9.1.2003. The unbecoming behaviour of both the top-most BJP leaders strengthened NSCN(IM) and other secessionist forces and weakened the patriotic section of the society. This they did in quest of becoming super-secular, neo-humanist and Gandhi-incarnate with an eye to capture the power for second term. To their misfortune, even after their buttressing the Christians and Muslims, they were thrown out from the Delhi throne. Their traditional support bases went against them for this reason while Christians and Muslims did not come to BJP’s support.

**NSCN(IM) Influences Opposition Leaders** :- A meeting with the leaders of the opposition and NSCN(IM) was held at the residence of former Prime Minister V.P. Singh and this was attended by Ram Vilas Paswan, Ram Jethmalani, Left leaders D. Raja, A.B. Bardhan, Sitaram Yechuri, Raghuvansh Prasad Singh (RJD), Human Right activist Swami Agnivesh and Abdul Rashid Saheen of National Conference. The three former Prime Minister of Bharatvarsh–V.P. Singh, Chandra Shekhar and H.D. Deve Gowda issued a statement appealing the concerned authorities to do the needful for the release of Th. Muivah who was undergoing jail term in Bangkok, Thailand from 19 Jan 2000 for traveling on fake visa. This meeting was held in July 2000.

**Beware of Pseudo–Gandhians and Human Rightists:** - NSCN(IM) is clever enough to knock every door to fulfil his anti-Indian demands. Muivah though imprisoned in Thai jail for traveling on fake visa, managed to organize a meeting of bipartisan participants from Thailand, Bharatvarsh and various international groups on 23<sup>rd</sup> July 2000 in Bangkok to discuss the NSCN-IM’s demands. The symposium resolved (i) to appeal Thai and Indian Government to recognize Muivah as an essential participant in the Indo-NSCN (IM) negotiations and therefore (ii) both the Governments should do the needful to release Muivah from Thai jail at Bangkok. On behalf of the 25 participants of this symposium, the above resolution was submitted to the Thai and Indian Governments. L.K. Advani got Muivah released from Bangkok jail after four months imprisonment. Some of the participants were-

**Nagalim for Christ: – Nagaland Baptist Council of Churches (NBCC) declared "Nagalim for Christ" which means that only Baptist Christianity is the recognized religion in Nagaland. Few years before at the end of 2<sup>nd</sup> millennium (2000), NBCC declared that 10,000 Naga missionaries were being trained to take the gospel in Bharatvarsh, Nepal, Bhutan and Myanmar. NSCN(IM) echoed this declaration of NBCC. Isak Chishi Swu, Chairman of NSCN(IM) revealed in an interview at Beverly Hills (USA) that Nagaland had 10,000 missionaries poised to take the gospel to nearby lands. **"We want to penetrate China, Cambodia, Burma, Vietnam, Laos, Nepal and Bhutan with gospel" he said, "and we have 10,000 Naga missionaries who are ready to go."** He said further that American Baptists gave American missionaries for our Naga people and 95 percent of Naga population have been converted (Eastern Mirror 29.08.2005). NSCN (IM)'s letter pad is marked with-**Nagalim for Christ** (Nagalim means Greater Nagaland). S.K. Arshing, self-styled Secretary, Ministry of Religious Affairs GPRN (NSCN-IM) has stated, **"The strong faith and hope of the GPRN (NSCN-IM) is in Christ alone and the faith and hope GPRN (Government of People's Republic of Nagalim–NSCN-IM) has been proclaiming, witnessing and mobilizing everywhere throughout the Naga inhabited areas even outside Nagaland and abroad that we the Nagas are for Christ"** (GPRN, Ministry of Religious Affairs, Circular dated Oking the 9<sup>th</sup> November 1998).**

**Nagas of Nagaland Reject NSCN-IM:** - Th. Muivah and his Tangkhul cohorts have killed thousands of non-Tankhul leaders-underground and overground both

from his Naga National Council (NCC) days onwards. The genocide of non-Tangkhul Nagas reached its peak in 1980 when Muivah and his lieutenants returned after armed training in China and after being born-again in Chinese Communism. He defected from Church-mothered NNC and formed National Socialist Council of Nagaland (NSCN) under deep influence of Chinese communism. NSCN then destroyed reportedly 300 Churches (Baptists) and killed hundreds of Church leaders, pastors and reverends throughout Nagaland mostly in Mon and Tuensang districts of Nagaland and bordering Naga inhabited areas of Myanmar. Due to Tangkhul favoritism of Muivah, a large section of non-Tangkhul Nagas viz – Angamis, Aos, Semas, Konyaks, Chakhesangs, Lothas and Hemi Nagas from Myanmar were under anxiety. They defected from NSCN and formed NSCN (K) under the leadership of S.S Khaplang - a Hemi Naga from Myanmar in 1988. Tangkhuls remained in parent body while most of the non-Tangkhuls came to Khaplang fold within nine years. NSCN(IM)'s camp was deserted and many cadres surrendered to Government and yet others defected to NSCN (K) and by 1997 NSCN (IM) was breathing its last. It had lost its ground in Nagaland. It had no bargaining capacity. If Government of Bharatvarsh could continue the then existing approach to Nagaland Government under Dr. S.C. Jamir and the policy of exterminating the Naga terrorism led by NSCN (IM), the situation in Nagaland, Manipur, Asom and Arunachal would have been different to the advantage of sovereignty of country. But it is a mystery that instead of crushing the insurgency, H.D. Dewegoda—then Prime Minister entered into a ceasefire agreement on 1<sup>st</sup> August 1997. This gave a new lease of life to NSCN(IM). Muivah made full use of ceasefire agreement as strength building period because Army returned to their barracks and NSCN(IM) militants came on road with arms. Muivah used Cease-fire period also to assassinate Dr. S.C. Jamir and all others who opposed genocide led by Muivah and his Tangkhul cadres and also all those who stood for the unity, integrity and sovereignty of Bharatvarsh. By the period upto

2005, it ran a parallel government in Nagaland and killed over a thousand of Nagas and attacked more including S.C. Jamir.

Today, NSCN(IM) has completed the circular journey and reached the starting point from where its started on 1.8.1997. The strength it gathered from 1997 to 2005, has diminished and all the non-Tangkhul cadres have deserted the Hebron Camp-the Headquarter of NSCN-IM, 30km. from Dimapur. On 22 April 2007, the Wungrum village known as NSCN(IM) village near Dimapur was attacked by 5,000 strong Naga mob. The twenty houses of NSCN (IM) Kilonsers (self styled Ministers) were burnt to ashes, a huge cache of lethal weapons was recovered without a single bullet-fire. NSCN(IM) leaders and cadres ran away from the village to escape the mob fury of anger fire. Because of rampant extortion on gun-point, mad-killings of innocent people without rhyme or reason, repeated brutal attacks on Dr. S.C Jamir and goondaism by Muivah's cadres, the towns, cities and villages of Nagaland are taking utmost care not to allow Muivah's cadres to enter into their vicinity. Several NSCN (IM) cadres were thoroughly thrashed and killed by public. The Dimasa Hindus-the worst sufferer because of Hebron headquarter of Muivah's NSCN-IM, have been demanding the removal of Habron camp. Now, other Nagas have also joined with Dimasas in their demand for removal of Hebron camp from their area. The Naga parents do not allow their grown-up children to join NSCN(IM).

Seeing the situation adverse to NSCN(IM), Isak Chishi Swu has secretly sneaked out of international border of Meghalaya and reached in Thai Capital - Bangkok. Muivah under Z-category security is almost a prisoner in his Hebron Camp licking the dust. He is seeing by his own eyes how Naga society is changed and they (Nagas) are happy to remain in Bharatvarsh. Witnessing his game plan getting fizzled-out, Muivah is spending sleepless nights in his Hebron camp. He is also looking for an opportunity to sneak out secretly to foreign country to escape the wrath of Naga people. Muivah had been cunning enough to coin different catchy slogans at different point of time to mesmerize Nagas. In the year 2000, he had



coined the word-reconciliation to bring all factions, politicians, NGOs and Church organizations into his fold. Last year (2007) he coined the slogan-Unification and several exercises were made. Several Unification meetings were held in Hebron camp. But this time it has fired back. In the name of Unification, all the Sema Cadres along with all other non-Tangkul militants have defected from NSCN-IM, they have deserted Hebron Camp and joined NSCN(K), while poor Muivah is watching this drama which wounded Muivah might have never dreamed of.

**The Reason for Disillusionment:** - There was a report in a Guwahati based media and also carried out by a Nagaland media that Muivah had amassed the wealth worth more than three hundred crores. He had purchased shares in different multi-national companies. The Nagas of Nagaland blame Muivah saying that Nagaland is not the Gaza strip in rehabilitating certain Nagas from outside Nagaland (meaning Tangkuls of Manipur). Through the name of Naga nationalism, lakhs of acres of land have been occupied at gun-point and palatial buildings established all over Nagaland and particularly Dimapur has been transformed to fortrees and safe haven for Muivah's blood-sucking goons for running smuggling of guns marijuana, heroin, vehicle theft, kidnapping, extortion, killings, rape and all other sorts of anti-social upheavals, "Go home! Muivah and brothers! There is no space for you over here! You can no more keep the Nagas at ransom. Your principle and ideology can no longer take the Nagas for a ride. We do not need your Amsterdam, UN, UNPO, Americas etc. but only peace. Leave us alone please or face the consequences. Dear Tangkul brothers, how long do you think your tribe should be at the mercy of Muivah's arrogance, hypocrisy and obstinacy? Ain't it the right time for your community to speak up and rein over Muivah and his communistic ideology for the sake of the Nagas and our political goal? Isn't there any sane and bold Tangkul intellectual or responsible leader to resist the destruction of the tribe and the Nagas merely at the whims of corrupted and egoistic leader in the form of Muivah?" **(Nagaland Post – 11/01/2008)**

**Isak Chishi Swu Proclaims Emergency:** - NSCN(IM) Chairman (Yaruiwo) Isak Chishi Swu has in a "Proclamation of Emergency", placed the Tatar Hoho (Cabinet of Ministers) of the NSCN(IM) under suspended animation with effect from January 13,2008.

Swu in the proclamation dated January 12, 2008, declared that an "emergency exists which increasingly threatens peace and normal state of affairs".

The proclamation also stated that the "state of affairs" shall be conducted by the National Security Council until further orders.

Meanwhile, NSCN(IM) sources told Nagaland Post that the Naga Army was given full power after the "external divisive forces" were interfering in the Naga internal affairs, thus causing a "threat to Naga sovereign rights". **(Nagaland Post – 13/01/2008)**

NSCN(IM) has stated that declaration of President Rule in Nagaland by government of Bharatvarsh is aimed at taking maximum upper hand on the Naga people and this has to be countered by the "self-styled" government of the People's Republic of Nagalim (GPRN-NSCN-IM). NSCN(IM) has declared emergency in Nagalim (Greater Nagaland) w.e.f. 1am. January 13, 2008 to counter the President Rule declared by GOI.

**Unification ? No, No ! Defection:** - NSCN(K) has be re-named as NSCN(Unification) after large number of NSCN(IM) cadres defected and joined the rival group NSCN(K). This NSCN(Unification) supports the president Rule in Nagaland while Naga Peoples Front (NPF) led by former Chief Minister of Nagaland Neiphiu Rio, BJP, NSF, NPMHR, NBCC and Naga Hoho are agitating against President Rule, **Dr. S.C. Jamir** - the author of **Bedrock of Naga Society** and a

staunch nationalist is reported to be the man behind clipping the wings of Muivah and his Tangkhul lieutenants. It is most anti-national act of BJP to torture and target a man like S.C. Jamir who is all out to protect the sovereignty of Bharatvarsh. The BJP is also targeting him at Goa for his frequent visits to Nagaland to handle the disturbed situation here. Can BJP afford to stoop so low? Why national leaders of BJP are ignoring the anti-national activities of some of the party leaders in Nagaland?

**How Foreigners with Doubtful Integrity Allowed to Enter into Nagaland: -**

How foreigners with hidden agenda of helping NSCN (IM) are allowed to visit sensitive, volatile and insurgency infested areas bordering China and Myanmar? These foreigners from USA, UK, Vatican, Australia and other Christian countries are coming to Nagaland and Manipur in the garb of Baptist reverends and Catholic priests to attend Christian functions. But their real motif is to assess the volatile situation in Nagaland and evolve the further strategy to help NSCN (IM) in closed door meetings.

**Some of the foreigners who visited Nagaland in recent past: -**

1. **UK** - The eleven member team from Southwick Christian Community Church England who arrived here on November 16, 2005 to help the Nagas, visited five places viz. Mokokchung, Akumen, Molunkimon, Kohima and Dimapur to provide resources so as to help the Christian Community to grow. They were – (1) Brian, (2) Bill, (3) Chris (4) Rev. (5) Lynda Hulcoop 5. John and six others (Northeast Herald 30.11.2005).
2. **Vatican**- The Apostle Nuncio and Vatican Ambassador to India visited Nagaland from October 24 to 26, 2005 to attend the closing ceremony of the Holy Eucharistic year of Catholic Church and the silver jubilee celebration at Mount Tabor Retreat House, Kohima. The Vatican Ambassador was received by Rt.Rev. Jose Mukala, Bishop of Nagaland and the meeting was attended by **Neiphiu Rio, Chief Minister of Nagaland**. Rio asked the Vatican Ambassador to carry Chief Minister's best wishes to Pope and other Catholic leaders in Vatican (The Northeast Sun 30.11.2005).
3. **British Church Leaders from Britain in Nagaland** – A four-member team of church leaders from Britain visited Nagaland on a mission to broker peace between NSCN(IM) and NSCN(K). The Church leaders, who belong to the **Religious**
4. **Society of Friends**, are commonly known as **Quakers**. A team from the American Baptist Church also visited Nagaland for a similar mission. NBCC (Nagaland Baptist Council Churches) hosted the visit.

**Central Government's Apathy:** - It is the duty of MHA to enquire properly (i) the aims, objects, area of operation, modus-operandi, mode of raising funds, (ii) proper utilization of funds (iii) the activity report in the light of works done on the ground and (iii) their involvement in anti-social and anti national activities (iv) bank account (v) proper maintenance of statement of income and expenditure but due (a) to inadequate inquiry infrastructure inside the country (b) lack of international network for effective checking and proper monitoring of foreign NGOs (c) rampant corruption (iv) nexus of politicians, bureaucrats, MNCs, mafia dons and terrorist organizations and (d) complacent beneficiary

group, the proper monitoring of activities, the necessary checks and adequate enquiries are not done at every level. As a result, running an NGO at national and international level has become a flourishing business.

When the Govt. fails (i) to maintain effective ground level contact with the people and (ii) to fulfill their wishes, the Govt. sector gets weakened and non-Govt. sector become very powerful. Today they are controlling parallel economy in the form of black money. In fact, there should be a harmony between NGO and Govt. Organizations (GOs) but this balance is disturbed in favour of NGOs due to failure

of Govt. machineries. This is the reason that foreign NGOs are successful in patronizing terrorist organizations like NSCN(IM) challenging the sovereignty of the nation. Should Govt. of Bharatvarsh not act decisively to check the anti-national activities of these NGOs who are helping NSCN(IM) and other terrorist organizations of their choice operating in NE region? Should GOI not be pro-active to finish Naga insurgency once for all? At the time of all the ceasefire agreements and succeeding years viz (i) Sixteen Point Agreement 1960 (ii) Ceasefire Agreement 1964

(iii) Shillong Accord 1975 and now (iv) Ceasefire Agreement 1997, the Naga Underground section of Nagas always scrapped when their strength building work was over. Each time they killed scores of Army jawans and innocent people to make their presence felt. This time, the GOI should not be caught unaware. Army should be empowered to tight the noose. **Armed Forces Special Power Act 1958 (AFSPA)** should remain in force, rather, it should be made more stringent. Govt. of Bharatvarsh must not succumbed to international pressure brought over by their Indian stooges present in our Parliament, Judiciary, Bureaucracy and the fourth estate – the media. The masked NGOs (national & international) and human-rightists mostly advocates/lawyers, retired judges and persons from socialist/communist background are required to be kept under strict surveillance and their international bases probed. Anybody found guilty of betraying the nation and committing crimes against the society and country should be awarded exemplary punishment because crime unpunished breeds criminals.

**The Responsibility of Civil Society:-** Drawing a lesson from Christian appeasement policy of Central Government overshadowed by Sonia Gandhi who is a rabid Christian fundamentalist and rank Hindu baiter, the Bharatiya Civil Society should have close vigil and monitoring mechanism for on-going peace-process between NSCN(IM) and GOI so that this time, GOI is prevented from committing gross national betrayal by agreeing to anti-national demands of Naga terrorists who are in league with Naga politicians and Naga bureaucrats.
